TERMS AND CONDITIONS

We reserve the right to make changes, modifications, amendments and/or updates to the terms in the Subscriber Agreement from time to time and for any reason, by posting such changes in this document, which you can access at any time by visiting: <http://dominicannetworks.com>, You acknowledge and agree that you shall be responsible for reviewing this Agreement from time to time for changes, and that changes to this Agreement shall be effective when posted. By continuing to use the Service after We have posted any such changes in the Subscriber Agreement, you are agreeing to be bound by all of the Subscriber Agreement, as amended, with respect to your use of “Dominican Networks apps” following the posting of such changes.

SUBSCRIPTION FEES AND PAYMENT; SUBSCRIPTIONS

Subscription Fees: You can find the current subscription fees and other charges for the Service (the “Fees”) posted on the Site pages where the Service is located. You agree to pay all subscription Fees and other Fees (including any applicable taxes) incurred in connection with your access to the Service and/or your Service Password (defined below), at the rates in effect when the charges were incurred. We may change the Fees, or add new Fees, upon prior notice to you either by e-mail or publishing the changes on the Site pages where the Service is located. You acknowledge and agree that you shall be responsible for reviewing the Service’s schedule of Fees from time to time for changes, and you further agree that changes shall be effective when posted on the Site pages where the Service is located.

For any Service subscriptions purchased via <http://dominicannetworks.com>, DOMINICAN NETWORKS shall be the seller of record for sales tax purposes, and, without limiting the generality of the foregoing, you agree to pay Us any taxes imposed on the sale of subscriptions or other products or services via the Service, for remission by DOMINICAN NETWORKS to appropriate taxing authorities. If you purchase a Service subscription using your account with a third party app store (e.g., Apple App Store, Google Play, Roku & Amazon), your purchase will be billed by that third party app store and will be subject to the additional terms-and-conditions governing the making of purchases via such store.

Payment: For any subscription you purchase, You authorize subscription Fees to be billed automatically to the means of payment you designate (for example, the PayPal account or credit card you designate via the Site, or the credit card you designate for a third party app store). You agree to provide a valid means of payment and accurate, complete and updated information required by the subscription registration form. By submitting your means of payment (e.g., credit card or PayPal account) as the form of payment, you represent and warrant that your use of such means of payment is authorized and that all information that you submit is true and accurate (including, without limitation, credit card and/or account number and expiration date). In doing so, you also authorize charges to your means of payment for all amounts payable by you based on the subscription/billing plan you selected, including, but not limited to, all Fees and any applicable taxes. Failure to comply may result in the immediate suspension or termination of your access to the Service. If you want to designate a different means of payment or need to update validity or expiration date information.

Unable-to-be-processed payments: If We are unable to process your means of payment at any time, your Service account may be immediately suspended or terminated and you will remain responsible for all amounts payable by you to Us. Your agreement with your credit issuer governs use of your credit card and the PayPal user agreement governs your use of the PayPal service.
